QUORUM COURT MEETING FEBRUARY 27, 2022

The Cross County Quorum Court held a regular meeting Monday, February 27, 2023, in the Lobby of the Cross County Courthouse at 6:00 p.m. Judge Lynn Blake called the meeting to order. Prayer was said by Justice Glenda Vance, and the Pledge of Allegiance was recited. The roll was called, and all Justices were present. Justice Carl Loewer made a motion to approve the minutes from the January 2022 regular meeting with Justice Scott May seconding it. A voice vote was taken, and all Justices were in favor.

Budget Reports: No report to be given.

Personnel Report: Justice Glenda Vance reported that the personnel committee met in February to review recommendations from Sheriff David West.

Building Report: No report to be given.

Road/Bridges Report: Justice Jerry Rushing reported that the road department has put in some culverts and has been grading the county roads between rains. He reported that with the recent weather conditions, it would be impossible for the road crews to be completely caught up. He also mentioned that the road department has been working on Saturdays when possible.

Sheriff Report: Sheriff David West stated he emailed the Quorum Court members his monthly report and jail audit. He said if any Quorum Court members had any questions, they could contact him.

Jessica Harris from the Wynne Senior Center spoke to the Quorum Court with a request for \$3,500 for the Senior Life Center to be able to continue daily meals. All meals come from St. Bernard's in Jonesboro, but the Senior Life Center must pay \$3.500 per year to cover the cost of the meals. Ms. Harris mentioned that she has applied for grants and other funding but hasn't been successful. The funding would cover the rest of their fiscal year, which is through June of this year. Judge Lynn Blake told the Quorum Court members that this was not a current ordinance on the agenda, but it could be brought before the budget committee in March to set an ordinance if the Justices wished to do so. Justice Glenda Vance made a motion to take it to the budget committee with Justice Anthony Jarrett seconding. All Justice presents voted in favor.
