The Cross County Quorum Court held a regular meeting March 21, 2022 in the Lobby of the Cross County Courthouse at 6:00 p.m. Judge Donnie Sanders called the meeting to order. Prayer was said by Judge Donnie Sanders and the Pledge of Allegiance was recited. The roll was called and all Justices were present. Justice Carl Loewer made a motion to approve the minutes from the February 2022 regular meeting with Justice Scott May seconding it. A voice vote was taken and all Justices present were in favor.

Budget Reports: Justice Lynn Blake reported a meeting was set for Monday, March 28, 2022 at 6:00 p.m. and welcomed all to attend.

Personnel Report: Justice Carl Loewer stated there is no report to be given.

Building Report: Justice Kevin Jumper stated there was no report to be given.

Road/Bridges Report: Justice Scott May reported that everything was good. Road graders were out and running.

Sheriff Report: Sheriff David West handed out his report and went over all the information.

The ordinance was read for the third reading by Justice Scott May. The roll was called to adopt the ordinance with all Justices voting yes. Ordinance No. 2022-7 has been duly adopted and recorded in the Quorum Court Book of Records.
