An Ordinance to be entitled: AN ORDINANCE TO ESTABLISH THE ANNUAL OPERATING BUDGET FOR THE CALENDER YEAR 2023: The ordinance was sponsored by the Cross County Budget Committee. The ordinance was read by Justice Anthony Jarrett. A motion to suspend the rules and place on second and third reading title only was made by Justice Glenda Vance with Justice Carl Loewer seconding it. A motion to place the ordinance on third reading title only was made by Justice Carl Loewer and seconded by Justice Glenda Vance. The roll was called, and all Justices present voted in favor. The ordinance title was read by Justice Anthony Jarrett for the third reading title only. A motion to adopt the ordinance was made by Justice Jerry Rushing and seconded by Justice Carl Loewer. The roll was called, and all Justices present voted in favor. Ordinance #2023-1 has been duly adopted and recorded in the Quorum Court Book of records.

An Ordinance to be entitled: AN APPROPRIATION ORDINANCE TO AMEND THE 2023 BUDGET, MOVING \$735,000.00 FROM UNAPPROPRIATED ROAD DEPARTMENT FUND 2000 TO ROAD DEPARTMENT LEASE PURCHASE LINE ITEM 2000-2003073: The ordinance was sponsored by Justice Carl Loewer.
