

ORDINANCE #2023-3

BE IT ENACTED BY THE QUORUM COURT OF CROSS COUNTY AN ORDINANCE TO BE ENTITLED:

WHEREAS: AN ORDINANCE TO AUTHORIZE CROSS COUNTY TO PURCHASE SERVICES FROM A.J. AUTOMOTIVE, ANDREWS WRECKER SERVICE, III D FARM & AG, LLC, AND DAVIS MACHINE SHOP AS PROVIDED BY ARKANSAS ANNOTATED CODE §14-14-1202;

WHEREAS: ARKANSAS ANNOTATED CODE §14-14-1202 (C)(2)(A) EXPLICITLY AUTHORIZES THE QUORUM COURT TO ACT IN THE BEST INTEREST OF THE COUNTY AND TO PERMIT THE COUNTY TO ALLOW PURCHASES DIRECTLY OR INDIRECTLY FROM RELATIVES OF COUNTY EMPLOYEES DUE TO UNUSUAL CIRCUMSTANCES;

WHEREAS: ANTHONY JARRETT, DBA A.J. AUTOMOTIVE, BRIAN ANDREWS, DBA ANDREWS WRECKER SERVICE, TREY DAVIS, DBA III D FARM & AG, LLC, AND BILL DAVIS, DBA DAVIS MACHINE SHOP ARE QUALIFIED AND AGREEABLE TO PERFORM OR RENDER SERVICES FOR CROSS COUNTY;

WHEREAS: THE QUORUM COURT OF CROSS COUNTY DECLARES THAT UNUSUAL CIRCUMSTANCES EXIST AS PROVIDED FOR UNDER ARKANSAS ANNOTATED CODE §14-14-1202 (C)(2)(A) AND THAT IT IS IN THE BEST INTEREST OF CROSS COUNTY TO ALLOW A.J. AUTOMOTIVE, ANDREWS WRECKER SERVICE, III D FARM & AG, LLC, AND DAVIS MACHINE SHOP TO PROVIDE SERVICES FOR CROSS COUNTY AS SET FORTH HEREIN;

WHEREAS: THIS COURT IS OF THE OPINION THAT THIS AGREEMENT IS FAIR AND REASONABLE.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF CROSS COUNTY, ARKANSAS.
