

WYNNE SENIOR CITIZENS CENTER MEAL PROGRAM

- St. Bernard's provides 150 meals per day at a cost of approximately \$7.70 per meal. The center feeds 98 meals per day in center. 42 meals are prepared and delivered to home bound clients. 43 clients are provided weekend meals.
- St. Bernard requires the Wynne center to provide \$3500 per year toward the cost of the meals, meanwhile, 34 clients are on a waiting list and are not being served.

Below is a breakdown of the costs.

Currently there are 743 meals per week provided at a cost of \$5878.50 per week.

St. Bernard's also provides meals to 5 other sites.

Cross County can not subsidize all the needed funds for the center. Cross County cannot commit to a yearly funding or grants. Cross County can give a onetime grant in the amount of \$3500.00 to help subsidize the meal program. These funds should come from the ARPA funds and the Senior Citizens Center would be responsible for receipts for all funds expended and all funds should be used for the meal program only.
