Prayer was said by Justice Jerry Brewster and the Pledge of Allegiance was recited. The roll was called and all Justices were present except for the vacant JP seat #2. Justice Carl Loewer made a motion to approve the minutes for January 2019 with Justice Glenda Vance seconding the motion. A voice vote was taken and all Justices present were in favor.
