The Cross County Quorum Court held a regular meeting July 15, 2019 in the lobby of the Cross County Courthouse at 6:00 p.m. Judge Donnie Sanders called the meeting to order. Prayer was said by Justice Jerry Brewster and the Pledge of Allegiance was recited. The roll was called and all Justices were present except Justice Lynn Blake. Justice Carl Loewer made a motion to approve the minutes for June 2019 with Justice Glenda Vance seconding the motion. A voice vote was taken and all Justices present were in favor.

The Resolution was read by Justice Carl Loewer. A motion was made by Justice Carl Loewer with Justice Glenda Vance seconding it. The roll was called and all Justices present voted yes. Resolution #2019-6 has been duly adopted and recorded in the Quorum Court Book of Records.
