CROSS COUNTY QUORUM COURT
ORDINANCE # _____

Be it enacted by the Quorum Court of the County of Cross, State of Arkansas, an Ordinance to be entitled:

An Amendment to the 2020 Budget to Appropriate \$3,000.00 from Unappropriated Funds to Three County Fair

An amendment to the 2020 Budget to appropriate \$3,000.00 from unappropriated County General fund to County General fund Grant-in-Aid Recreation and Culture line item #1000-6023164.

Whereas, the Three County Fair provides opportunities for the residents of Cross, Jackson and Woodruff Counties that the counties would not individually be able to offer its residents; and

Whereas, the 4-H program of Cross County sponsors the Youth Day activities of the Three County Fair in conjunction with the other counties' 4-H programs to provide outdoor activities to the youth of our county including bait casting, craft and talent shows, and many other activities; and

Whereas, the Three County Fair offers state qualifying pageants to the youth of our area that participate in those activities; and

Whereas, the Three County Fair offers rides and games to the attendees, has a talent show for youth, and a mud bog with activities changing annually depending upon interest; and

Whereas, the Three County Fair offers contests that judge the many wares that are locally produced by our residents, including jellies, jams, melons, fruits, chickens, flowers, and quilts, by young and old alike; and

Whereas, the Three County Fair celebrates the many great qualities of life that the Delta has to offer all who live here;

Whereas, it is necessary to amend the 2020 Budget to appropriate \$3,000.00 from unappropriated County General fund to County General fund Grant-in-Aid Recreation and Culture line item #1000-6023164;

Now, therefore, be it resolved by the Quorum Court of Cross County, Arkansas,
that:

The benefits provided to the residents of Cross County by the Three County Fair are worthy of the continued support of this court and is appropriated \$3,000.00 from unappropriated funds to the Three County Fair, being the opinion of this court that this appropriation is fair and reasonable.
