BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF CROSS, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE TO AUTHORIZE THE COUNTY TO PURCHASE SERVICES OF DAVID WINKLER, T.J. WHEELER AND BILL DAVIS AS PROVIDED BY ARKANSAS ANNOTATED CODE §14-14-1202;

WHEREAS: ARKANSAS ANNOTATED CODE §14-14-1202 (C) (2) (A) EXPLICITLY AUTHORIZES THE QUORUM COURT TO ACT IN THE BEST INTEREST OF THE COUNTY AND TO PERMIT THE COUNTY TO ALLOW PURCHASES DIRECTLY OR INDIRECTLY FROM RELATIVES OF COUNTY EMPLOYEES DUE TO UNUSUAL CIRCUMSTANCES;

WHEREAS: DAVID WINKLER, CPA, IS QUALIFIED AND AGREEABLE TO PERFORM OR RENDER SERVICES TO THE CROSS COUNTY SHERIFF'S OFFICE;

WHEREAS: T.J. WHEELER, CDL LISCENSED, IS QUALIFIED AND AGREEABLE TO PERFORM OR RENDER SERVICES TO THE CROSS COUNTY ROAD DEPARTMENT;

WHEREAS: BILL DAVIS, MECHANIC, IS QUALIFIED AND AGREEABLE TO PERFORM OR RENDER SERVICES TO THE CROSS COUNTY ROAD DEPARTMENT AND JUDGES OFFICE;

WHEREAS: THE QUORUM COURT OF CROSS COUNTY DECLARES THAT UNUSUAL CIRCUMSTANCES EXIST AS PROVIDED FOR UNDER ARKANSAS ANNOTATED CODE §14-14-1202 (C) (2) (A) AND THAT IT IS IN THE BEST INTEREST OF CROSS COUNTY TO ALLOW DAVID WINKLER, T.J. WHEELER AND BILL DAVIS TO PROVIDE SERVICE TO CROSS COUNTY AS SET FORTH HEREIN.
