The Cross County Quorum Court held a regular meeting November 16, 2020 in the lobby of the Cross County Courthouse at 6:00 p.m. Judge Donnie Sanders called the meeting to order. Prayer was said by Justice Jerry Brewster and the Pledge of Allegiance was recited. The roll was called and all Justices were present. Justice Carl Loewer made a motion to approve the October 2020 minutes with Justice Gary Eakin seconding the motion. A voice vote was taken and all Justices were in favor.

The Voice recorder malfunctioned. I have no new business to report.

RESOLUTION – Fill Treasurer Vacancy: A motion was made by Justice Jerry Brewster with Justice Doug Kennon seconding it. The roll was called and all Justices voted yes to be tabled.

An Ordinance to be entitled: AN ORDINANCE APPROVING THE COLLECTION FOR THE YEAR 2020 THE VARIOUS TAXES HERETOFORE IMPOSED IN CROSS COUNTY, ARKANSAS. The Ordinance was read by Judge Donnie Sanders. A motion was made by Justice Lynn Blake with Justice Carl Loewer seconding it. The roll was called and all Justices voted yes. Ordinance #2020-15 has been duly adopted and recorded in the Quorum Court Book of Records.

An Ordinance to be entitled: AN ORDINANCE TO AMEND THE 2020 BUDGET TO ESTABLISH FOR ALL FULL TIME AND PART TIME EMPLOYEES AND ALL COUNTY ELECTED OFFICIALS, INCLUDES QUORUM COURT, SURVEYOR, AND CORONER A ONE TIME SUPPLEMENT, DUE TO THE EFFORTS OF COUNTY DEPARTMENTS TO ADHERE TO THE 2020 BUDGET. The Ordinance was read by Justice Doug Kennon. A motion was made by Justice Jerry Brewster with Justice Doug Kennon seconding it. The roll was called and all Justices voted yes. Ordinance #2020-16 has been duly adopted and recorded in the Quorum Court Book of Records.

An Ordinance to be entitled: AN ORDINANCE TO ESTABLISH THE ANNUAL OPERATING BUDGET FOR THE CALENDER YEAR 2021. The Ordinance was read by Jude Donnie Sanders. A motion was made by Justice Gary Eakin with Justice Doug Kennon seconding

it. The roll was called and all Justices voted yes. Ordinance #2020-17 has been duly adopted and recorded in the Quorum Court Book of Records.

An Ordinance to be entitled: 2021 BUDGET FUND TOTALS. The roll was called and all Justices voted yes. Ordinance #2020-18 has been duly adopted and recorded in the Quorum Court Book of Records.

A motion to adjourn was made by Justice Carl Loewer and seconded by Justice Scott May. A voice vote was taken and all Justices were in favor. Meeting was adjourned.
