QUORUM COURT MEETING MARCH 2, 2021

The Cross County Quorum Court held a special meeting March 2, 2021 in the court room of the Cross County Courthouse at 6:00 p.m. Judge Donnie Sanders called the meeting to order. Prayer was said by Judge Donnie Sanders and the Pledge of Allegiance was recited. The roll was called and all Justices were present except Justice Gloria Aldridge.

An Ordinance to be entitled: AN ORGANIZATIONAL ORDINANCE FOR THE 2021-2022 QUORUM COURT. The Ordinance was read by Justice Kevin Jumper. A motion was made by Justice Kevin Jumper with Justice Carl Loewer seconding it. Justice Kevin Jumper made an amendment to change the Quorum Court meetings each month to 6:00 pm with Justice Carl Loewer seconding it. The roll was called and all Justices present voted yes. Ordinance #2021-5 has been duly adopted and recorded in the Quorum Court Book of Records.

An Ordinance to be entitled: AN AMENDMENT TO THE 2021 BUDGET TO APPROPRIATE \$12,419.65 FROM UNAPPROPRIATED COUNTY GENERAL FUND TO SHERIFF'S DEPARTMENT FUND LINE ITEM #1000-4001001 AND \$950.10 TO LINE ITEM #1000-4001006, \$11,012.00 FROM UNAPPROPRIATED COUNTY GENERAL FUND TO JAIL FUND LINE ITEM #1000-4181001 AND \$842.42 TO LINE ITEM #1000-4181006, \$1,702.15 FROM UNAPPROPRIATED COUNTY GENERAL FUND TO 911 FUND LINE ITEM #3020-5011001 AND \$130.21 TO LINE ITEM #3020-5011006 AND \$9,316.17 FROM UNAPPROPRIATED ROAD DEPARTMENT FUND TO ROAD DEPARTMENT FUND LINE ITEM #2000-2001001 AND \$712.69 TO LINE ITEM #2000-2001006. A motion was made by Justice Lynn Blake with Justice Glenda Vance seconding it to amend the ordinance to add \$2635.43 for matching benefits that was left out of the ordinance. The roll was called and three Justices voted no and five voted yes. A motion was made by Justice Lynn Blake to suspend the rules and put the ordinance on second reading, title only with Justice Scott May seconding it. The roll was called and three Justices voted no and five voted yes. Justice Lynn Blake read the ordinance by title only for the second reading. 

A motion was made by Justice Lynn Blake with Justice Scott May seconding it. The roll was called and all Justices present voted yes. Resolution #2021-1 has been duly adopted and recorded in the Quorum Court Book of Records.

Judge Donnie Sanders appointed Justices for the committee boards.

A motion to adjourn was made by Justice Lynn Blake and seconded by Justice Scott May. A voice vote was taken and all Justices present were in favor. Meeting was adjourned.
