AN AMENDMENT TO THE 2021 BUDGET TO APPROPRIATE \$84,086.49 FROM UNAPPROPRIATED COUNTY GENERAL FUND TO COUNTY JAIL FUND FOR TWO (2) ADDITIONAL JAILERS FOR THE CROSS COUNTY DETENTION CENTER AND \$32,086.69 FROM UNAPPROPRIATED GENERAL FUNDS TO COUNTY SHERIFF FUND FOR ONE (1) NEWLY CREATED RECEPTIONIST POSITION AT THE NEW CROSS COUNTY SHERIFF'S OFFICE AND DETENTION CENTER;
