QUORUM COURT MEETING APRIL 18, 2022

The Cross County Quorum Court held a regular meeting April 18, 2022 in the Lobby of the Cross County Courthouse at 6:00 p.m. Judge Donnie Sanders called the meeting to order. Prayer was said by Justice Glenda Vance and the Pledge of Allegiance was recited. The roll was called and all Justices were present. Justice Lynn Blake made a motion to approve the minutes from the March 2022 regular meeting with Justice Carl Loewer seconding it. A voice vote was taken and all Justices present were in favor.

Budget Reports: Justice Lynn Blake stated there was no report to be given.

Personnel Report: Justice Carl Loewer explained that he attended the AAC Meeting.

Building Report: Justice Kevin Jumper stated there was no report to be given.

Road/Bridges Report: Justice Scott May stated they were waiting on the weather to clear so they could get back out on the roads.

Sheriff Report: Larry Jones handed out the Sheriffs Office report and went over all the information.

Mr. King from Cross County Rural Water came forward to discuss his request for ARP Funds to help with decreasing the calcium issues in the water within the county. No action was taken at this time. Justice Glenda Vance said she would sponsor the ordinance.

A Resolution to be entitled: PROVIDING FOR INTERIM FILING OF VACANCIES FOR THE OFFICE OF COUNTY JUDGE AND SHERIFF DURING TIMES OF EMRGENCY. The Resolution was read by Justice Lynn Blake. Justice Scott May made a motion to accept with Justice Kevin Jumper seconding it. A voice vote was taken. All Justices present voted yes. Resolution 2022-2 has been duly adopted and recorded in the Quorum Court book of records.

An Ordinance to be entitled: AN ORDINANCE TO ESTABLISH A COUNTY BUDGET ENTITLED ARP COUNTY GENERAL: The Ordinance was read by Justice Carl Loewer. A motion to accept was made by Justice Carl Loewer with Justice Gloria Aldridge seconding it. Justice Kevin Jumper made a motion to amend the Ordinance to establish all funds to ARP General with Justice Jerry Rushing seconding it. The roll was called with all Justices present voting yes except Justice Carl Loewer, Justice Gloria Aldridge, Justice Lynn Blake and Justice Glenda Vance voting against. The Amendment passed. A roll call vote was taken to pass the Amended Ordinance to appropriate \$2,596,956.75 to the ARP County General Fund. All Justices voted yes except Justice Lynn Blake.

Ordinance No. 2022-8 has been duly adopted and recorded in the Quorum Court Book of Records.

Some public comments were made.

A motion to adjourn was made by Justice Lynn Blake and seconded by Justice Gloria Aldridge. A voice vote was taken and all Justices present were in favor. Meeting was adjourned.
